This program is for families who earn between 50-80% of the area median income. Homeowners provide sweat equity hours towards their home, make a \$2,000 down payment, and assume a 20 to 40 year low interest mortgage. Homeowners are selected based on need for housing, willingness to partner with Habitat and ability to repay a loan.

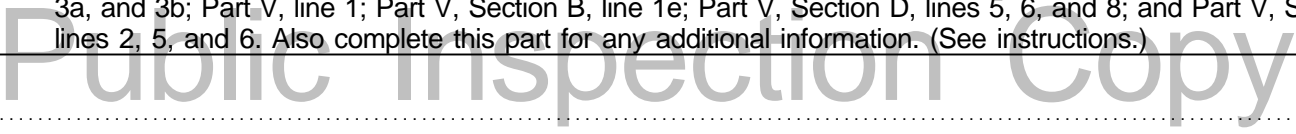
